My Reply:

Jonathan,

You are not going to like the answer to your question. First of all, you must realize that the illegal alien that sits in the white house cannot prove that he is even a citizen of the United States. He cannot prove he was born in Hawaii. Soetoro (aka BHO) claims on his book jacket that he was born in

Kenya! This makes him a Kenyan citizen since his daddy was a Kenyan "TRIBESMAN". Soetoro is also a British subject since he was born in Kenya under the British protectorate rule. And currently this makes him a former citizen of the EU (all 27 countries) (Britain will soon depart from the EU). Soetoro later became a citizen of Indonesia. He traveled to Pakistan on either a Indonesian passport or a Kenyan passport. No US passport for him can be uncovered from the State Department. Hence all the lawsuits demanding that this lying Muslim-Marxist-Kenyan-Indonesian prove his citizenship before he be given the nuclear codes of our military! You see how well THAT went!

Now to answer your question...(there is no way to VERIFY these figures!)

There have been 300+ ballot challenges cases against Soetoro. He, of course, was allowed free defense from government paid attorneys. People like me were NOT allowed this luxury. Personally I have spent over \$10,000 out of my own pocket bringing all the cases that I have been involved in (State + appeals & Federal + Appeals). This is in ADDITION to the pro-bono costs of my attorneys! Gary Kreep, Orly Taitz, Nathan Oleson and finally William J. Olson, PC who handled my US Supreme Court appeal all paid tens of thousands of dollars out of their OWN POCKET to take over my cases at their own expense.

In most of the cases there was at least one (free for Soetoro) GOVERNMENT ATTORNEY (usually making \$50 per hour). Most cases have at least 100 hours billed to the tax payers. I estimate that \$500 per case time 300 cases is a mere \$150,000 for all 300 cases... not too bad, right?

But in our case, Soetoro had his own private attorney as did many of the other cases. The law firm that handled these cases normally charge \$500 per hour. Each case billed AT LEAST 1000 hours during the 1-2 years of litigation. Each case had to cost at least \$500,000 for each case. I would be absolutely surprised if \$150,000,000 (300 x \$500,000) has not been spent since 2009 for all 300 cases that have been thrown at the illegal alien in the white house.

In 2010 Berg estimated that \$2,000,000 had been spent up to that point on defending the illegal thug. My estimate in 2016 IS MUCH HIGHER! My estimate is this figure of upwards of \$150M! And this is not even considering the Judges time, bailiffs, court clerks, and other misc costs. If you want to add those in... another million or so? This is the best I can do!
